ACCOMMODATIONS INCLUDE 2 BEDROOM/1 BATH APARTMENTS AND 3 BEDROOM/1 1/2 BATH APARTMENTS. EACH APARTMENT IS EQUIPPED WITH A REFRIGERATOR, STOVE, AND DISHWASHER.
